To make payment via **Cheque or Money Order** make sure to make them out to **TAFE NSW**.

Terms and Conditions

1. The TAFE NSW Fee is set by TAFE NSW and is mandatory for all courses offered by the College. **Please be aware that until fees are paid, a concession fee is paid or an exemption has been granted the student has not completed enrolment and therefore, is not enrolled.** Students who are not enrolled will not be entitled to attend class, will not receive a logon for necessary online services and will not have access to various resources and benefits such as sitting for examinations, receiving educational awards, utilising amenities and services (including travel passes and concessions), receiving an active TAFEcard (which provides access to Library resources) or receiving Austudy.
2. If you are not an Australian citizen or permanent resident of Australia or a New Zealand citizen you may need to pay an hourly tuition fee in addition to the fees and charges stated above. TAFE NSW conducts audits of residency status. Bradfield Senior College is part of TAFE NSW.
